additional safeguards such as firewalls. We also make efforts to limit access via passwords. The need for access is periodically reviewed.

All these measures are intended to prevent the loss, misuse, or unauthorized access, disclosure, alteration, or destruction of the personal information you provide or information we collect through this website.

Protection of Data

We take precautions to protect the security of your information. We have electronic and managerial procedures to help safeguard, prevent unauthorized access, maintain data security and correctly use data.

Alfa O and O only provide information about services, news updates, and job opportunities on our website. We will never ask for credit/debit card details, banking details, or any sensitive information from you. Below are the measures put in place to secure your personal information.

Data Security

We implement and maintain appropriate safeguards in protecting personal data. We offer the use of a security server. All actions and information are transmitted via Secure Socket Layer (SSL) technology and then encrypted only to be accessible by those authorized with special access rights on the system and are required to keep the information confidential.

Violation of Privacy Policy

Retention of Data

We will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of our Website, or we are legally obligated to retain this data for longer periods.

Your Data Protection Rights

- The right to withdraw consent:
- You also have the right to withdraw your consent at any time where Alfa O and Orelied on your consent to process your personal information.
